

EXHIBITS TO INCLUDE VEGETABLES/ FRUITS/ HERBS

Special Rules:

1. Entry open to any resident of Webster and surrounding counties.
2. There will be: adult classes (18 years & older) and youth classes (17 years & younger).
3. Exhibitors may make more than one entry if each entry is a different kind, variety or cultivar.
4. Exhibits must be fresh plant materials grown by exhibitor.
5. No pre-fair entries are needed – entries will be taken from 8:30 a.m. to 10:30 a.m., Friday, July 15, 2022.
6. No Entry Fee
7. Exhibitors will exhibit freshly harvested vegetables in accordance with the rules in Pamphlet 4H-462 entitled “Harvesting and Preparing Vegetables for Exhibits”. This pamphlet is available at the Webster County Extension Office, Wells Fargo Building, Downtown, Fort Dodge or online <https://store.extension.iastate.edu/Product/4h4662-pdf>. Categories mentioned in 4H-462 are encouraged with any other fruit or vegetable worthy of exhibiting to be entered. Please note the “Judging Pointers” found on pages 1 and 2. Paper plates and exhibitor tags will be furnished free.
8. Exhibits will be released at 4:00 p.m. Friday, July 15, 2022. OFFICIALS WILL NOT BE RESPONSIBLE FOR EXHIBITS REMAINING AFTER 4:40 P.M. Since the building will be used for other events, it is very important that you pick up your exhibits or make arrangements.
9. Exhibitors fill out exhibitor tags. Label vegetable/fruit/herbs exhibits to indicate the kind, variety and/or cultivar. An exhibit should have the following number of specimens per size unless otherwise stated in publication 4-H 462, “Harvesting and Preparing Vegetables for Exhibit”. Large: 1 specimen Medium: 3 specimens Small: 6 specimens
10. Judging will begin at 11:00 a.m., Friday July 15, 2022
11. All entries will receive a ribbon placing of blue, red or white, depending on quality.
12. Exhibits will be released at 4:00 p. m. Friday, July 15, 2022. OFFICIALS WILL NOT BE RESPONSIBLE FOR EXHIBITS REMAINING AFTER 4:00 PM. Since the building will be used for other events, it is very important that you pick up your exhibits or make arrangements.

PRIZES:

Prizes are furnished by the Fort Dodge Area Gardeners and awarded strictly according to the decision of the judge.

1. Adult “Best of Show” entry will be awarded \$10.00. Youth “Best of Show” entry will be awarded \$5.00.
2. All entries will receive a ribbon placing of blue, red or white.
